In consideration of the payment of the fee prescribed for this permit, permission is hereby granted to the registered owner identified on the face of this Certificate and the driver to use and operate the vehicle(s) described, in accordance with the provisions of the Commercial Transport Act and the terms and conditions shown on this permit, and while displaying on the windshield, a sticker issued pursuant to this permit.
